Welcome to the 14th year of ACS TQIP. Many of you are continuing TQIP participants, and some centers are new to TQIP this year. We are pleased to inform you that there are over 875 program participants across all levels of TQIP. In this document, you will find an overview of the program components for this year.

Please note that we will update the Participation Guide as any details change. As a dynamic program, TQIP adapts as needed and therefore we may adjust timelines and other plans, etc. throughout the program year.

ACS TQIP Components

TQIP Reports

TQIP benchmark reports compare outcomes, using both risk-adjusted and risk-stratified approaches, for all patients meeting TQIP inclusion criteria. Results are provided using a series of patient and injury characteristic cohorts (i.e., aged 65+ or shock patients). We typically provide two reports a year, one in the spring and one in the fall, and the data included in each report is as recent as six months post-discharge.

We currently offer risk-adjusted models for mortality, major hospital events, and major hospital events including death for all TQIP participation types (Adult, Pediatric, and Level III). We model each of these three outcomes in 8 Adult TQIP patient cohorts, 6 Pediatric TQIP patient cohorts, and 3 Level III TQIP patient cohorts. Additionally, we model a series of specific hospital event outcomes in targeted cohorts for the Adult Program and offer a Time to Transfer model for the Level III program. In total, this amounts to more than 60 risk-adjusted models across all TQIP participation types. We also provide a series of risk-stratified outcomes for a variety of cohorts for each participation type.

TQIP reporting is a dynamic environment— always stay tuned for updates and changes with each reporting cycle!

Dynamic Online Reporting Tools

TQIP participants have access to dynamic reporting tools which are available online and released in conjunction with each reporting cycle. These tools are designed to complement the results presented in the static bi-annual Risk-Adjusted Benchmark Report.

These tools allow participants to explore trends in user-defined patient cohorts, locate and correct data quality issues, and identify patients who are most suggestive of trends and opportunities for improving care. We see these tools as integral components of successfully using the TQIP Benchmark Reports to drive change in your institution.

Data Quality

The fundamental value of TQIP depends upon the availability of *consistent* and standardized data, as provided by participating centers. TQIP data elements directly overlap with existing NTDS data elements, but with additional TQIP-specific elements required for Level 1 and Level 2 participants. TQIP data submissions are also subjected to a TQIP-specific Validator that accommodates both the additional elements reported from Level 1 and Level 2 centers and the modified TQIP submission schedule for all centers.

The first test of data quality for TQIP centers is the Validator. The Validator checks for invalid and inconsistent data and rejects files that contain serious flags. Please review the <u>Validation Summary Report</u> that results from your data submission and correct flags, if needed. If you are missing any TQIP-specific fields in your submission file, contact your vendor as missing fields will affect your data and TQIP Benchmark Reports.

Additionally, please review the <u>Submission Frequency Report</u> generated after a successful submission to ensure the data from your trauma registry are mapped correctly. The Submission Frequency Report will ensure the data submitted from your facility is an accurate representation of your registry.

TQIP centers are required to make quarterly data submissions to provide contemporary data for analysis. This process allows for many advantages in terms of data quality and usefulness over submitting data on an annual basis. With a quarterly schedule, we are able to provide more contemporary reports and offer feedback on your patient outcomes

sooner after transmitting data to us. This affords your team the ability to act more swiftly on improvements to patient care. In addition, we are scrutinizing more current data as we assess data quality issues.

TQIP Quarterly Data Collection Process:

- We will call for data each quarter on the schedule below.
 There is no need to resubmit your data during the NTDB Annual Call for Data.
- Ideally, hospitals will follow the quarterly schedule and transmit contemporary data within the two months following the end of each quarter.
- However, we know that some hospitals may lag behind our schedule, as they may need to correct problems in alreadysubmitted records or send records that were not closed in an earlier quarter due to long LOS.
- We are allowing submission of records that were not previously sent, or were updated since the last quarterly submission, but they must conform to the admission and discharge dates shown in the third column below.
- Records will always use the Data Dictionary and Validator of their respective admission year.
- Data files must be separated by admission year. If you are submitting data from two different admission years, you will need to send two separate files.
- Any re-submitted record will overwrite its existing version in the database if there is a change from the original record.

Prior to each deadline, more specific details and instructions will be provided.

If you have concerns about how data quality is affecting your TQIP results, please contact TQIP staff. We will help you to conduct a review of your data coding and mapping practices, focused on those specific fields important to TQIP analysis.

The TQIP external data validation process monitors data quality by examining centers' benchmark reports and quarterly data submissions, which prompts Data Quality Reports or possible targeted site visits for a more detailed validation review using case abstraction. This process provides more contemporary feedback on data reliability and helps discover issues that could affect centers' risk-adjusted benchmark results.

Major TQIP communications will come from traumaquality@email.facs.org Please add these email addresses to your list of accepted senders to ensure you receive all TQIP communications.

Any staff changes or updates can be managed by facilities on the <u>ACS</u> <u>Quality Portal (QPort)</u>. This will ensure that the correct staff at your center are notified of important TQIP events, changes, educational offerings, and reports. TQIP Education and Training

Registry education is an important underpinning of data quality and standardization. TQIP offers online continuing education modules that empower participants to pace their own education and focus on topics most relevant to their role at the trauma center. These modules are deployed on a rolling schedule throughout the year and cover various topics such as the NTDS, data quality, the TQIP benchmark report and an overall background of TQIP. Each module takes approximately 1 hour to complete, and CEs are provided after completion of each module. The TQIP online continuing education modules are housed on the TQIP Education Portal and are available to all enrolled staff at all participating TQIP centers for no additional cost. TQIP also provides non-punitive monthly educational experiences, and scheduled web conferences, for all staff who are involved in TQIP at each center. In order to determine the focus of the educational experiences, we carefully examine data quality concerns and take into consideration comments and questions we receive from participants about data elements, data submission, and all TQIP reporting products. Educational experiences are sent via email. The web conferences are learning opportunities which will cover a variety of topics for all hospital staff involved in the TQIP team and will often provide continuing education credits. Web conference announcements are sent via email and recordings are uploaded to the TQIP Education Portal. These learning opportunities apply to all hospital staff involved in the TQIP team.

Best Practice Guidelines

The Trauma Quality Programs Best Practices Guidelines emerged from a growing need to provide trauma centers with recommendations for managing patient populations or injury types and have become a highly regarded publication from the ACS. These Guidelines are written by leading medical experts and provide a valuable resource for trauma centers.
